

House Rules March 2024

The following house rules govern the behavior of our members. The person in charge at the time (Post Commander, an officer, a bartender, or a security person) will enforce these rules. Flagrant violators will be immediately suspended from all activities for a period not to exceed two weeks pending an investigation of the violation.

Membership Card: A current membership card must be produced upon request. If the patron cannot produce a card, he or she must be signed in by a cardholding member or leave.

Point of Entry: For security reasons, entry to the building will be with a key card at the front door only. All other doors must be closed unless a special event is taking place. Special events require door monitoring, and all entrants must sign in at the entryway.

Key Card Usage: Key cards are issued for security and convenience to members who frequent the club regularly. Key cards are not a substitute for member identification. Members are still required to have an active membership card on their person to enter the club.

Guests: An active member must sign in guests and is responsible for their conduct. It is the member's responsibility to ensure the guests leave when they do.

Off Limits Areas: The kitchen, meeting hall, office areas, and the area behind the bar are off limits without permission from an officer or the bartender.

Smoking Areas: Designated smoking areas are the back patio and the north side of building.

Suggestions and Criticisms: No member shall verbally reprimand or abuse an officer or employee of the post. Any suggestions or criticisms will be submitted in writing in accordance with current post regulations.

Profane Language: Profane language will not be tolerated.

Aggressive Actions: Abusive or aggressive actions or language will not be tolerated which includes indiscriminate shouting or yelling.

Care of Property: Any member removing (without proper permission), damaging, or destroying post property must pay for the loss or damage. The Commander will determine if further Legion action is warranted in cases of theft.

Nuisances: A member can be deemed to be a nuisance or perpetrator if they (1) make dispersions or unwanted advances toward any individual or group of individuals, (2) physically and continually, whether intentional or not, intrudes upon an individual's personal space, or (3) deliberately sits or otherwise places themselves where they are not wanted.

Sales to intoxicated Persons: It is a violation of the Liquor Control Act for a person to sell, deliver or serve alcoholic beverages to or to procure or aid in the procurement of alcoholic beverages for an intoxicated person. The bartender on duty is required to suspend service to any person that appears to be intoxicated. Further they can suspend service and eject from the club any person attempting to procure alcohol for an intoxicated person. The bartender should secure transportation for an intoxicated person with a non-intoxicated person or by calling a commercial taxi.

Notice to Leave: Once a patron is refused service or requires severe corrective action, he or she must immediately leave the premises or risk having their post privileges revoked.

Underage Persons: No one under age 21 years of age is permitted at the bar at any time. No one under the age of 21 is permitted in the lounge area (tables), game room, or event hall after 6PM unless under the supervision of an adult. Valid government issued ID required. Vertical State IDs only accepted with valid temporary horizontal ID.

Taking Alcohol Outside: Drinks are only permitted outside under the covered patio and the north alleyway up to the Lounge door.

Gambling Age: Gaming of any type is only permitted for patrons 21 and older.

Cashing Checks: The post does not cash checks. The ATM is available for the purpose of obtaining cash. Members with the approval of the Post Commander or the Finance Officer, may cash checks up to \$100 only if the ATM is out of service. Returned checks are considered a violation and will incur a \$35 returned check fee. No two-party checks will be accepted.
